As Friends of NCHS, we write to thank you for your support for the National Center for Health Statistics thus far in the FY 2023 appropriations process. NCHS provides enormous value to the US public health infrastructure at the national, state, and local levels, for researchers and policymakers alike. The additional investment in both chambers of \$10 million in NCHS would allow the agency to create a more responsive twenty-first century statistical agency and reaffirm NCHS's status as the world's gold-standard producer of health statistics. We therefore respectfully request enactment of at least \$190.4 million in FY23.

A key lesson of the Covid19 pandemic and being ready for the next public health crisis is to have more timely, frequent, and granular data available on America's health and healthcare. NCHS can more quickly help to fulfill that gap with additional funding for modernization and diversification of its data collection efforts, and for data modeling and analysis capabilities. The [Friends of NCHS FY23 priorities document](#), endorsed by 56 organizations, elaborates on how NCHS can immediately put additional investment to effective use in producing more timely, frequent and granular data.
